- This CFA registered Maine Coon cat or kitten is sold as a Pet/Spay/Neuter
- The Purchaser will have the kitten altered/spayed before sexual maturity (around 6-7 months for a female). Males may be kept whole longer up to 8 months to allow the characteristic muscle and boning to develop. Purchaser understands that the registration papers will be marked "not for breeding" and CFA will not register any of said cat's offspring. Purchaser will send CJPAWS a copy of the altered/spayed receipt from a licensed veterinarian once the surgery is performed.
- Kittens sold as pets will not be shown in competition without permission of the breeder.

HEALTH GUARANTEE

- CJPAWS guarantees that this kitten or cat is in good health
- This kitten/cat has been immunized against Feline Infectious Enteritis, Feline Rhinotracheitis and Calici Virus, and Chamydia.
- This cat has no fleas, ear mites, or other external or internal parasites

- This cat is guaranteed to be FeLV and FIV negative
- This cattery is FIP negative

- Purchaser agrees to have this cat examined by a licensed veterinarian within 48 hours (excluding weekends) from the date of this contract to confirm the cat's healthy condition.
- CJPAWS's health guarantee extends for one week from the date of this contract. If within the guarantee period, the cat is shown to be sick by a licensed veterinarian, the purchaser agrees to either:
- Return the cat to CJPAWS and then to be returned to the Purchaser when the health is restored or at the Purchaser's request, CJPAWS will provide a full refund of the purchase price.

- The purchaser agrees to the following:
 - Purchaser will have this cat immunized annually and follow a veterinarian's advice in all matters pertaining to the care of this kitten or cat
 - The cat will be given the proper diet in the proper amount, as specified in writing at the time of the sale and will have fresh water available at all times
 - The cat will receive frequent and kind human attention
 - Purchaser will keep this kitten/cat as long as it lives unless unusual circumstance prevent. If it becomes necessary for the purchaser to give the cat up, the purchaser will contact CJPAWS for the right of first refusal for no more than the purchase price, excluding shipping fees. CJPAWS will assist the Purchaser in finding a suitable home for the cat if necessary. CJPAWS must be contacted before this cat changes hands
 - No cat/kitten from this cattery may be sold or given to an animal shelter, sold or given to a pet store, abandoned or sold or given to a laboratory.
 - If the buyer, having put a deposit on a cat, should later change his or her mind about the purchase, the deposit will be refunded upon re-sale of the cat or kitten for at least as much as \$_____ (the original quoted price). If the cat or kitten must be re-sold for less than \$_____, the deposit will be refunded, less the difference between \$_____ and the re-sale price.
